

BitOasis - USD 30,000 Trading Championship Promotion - Terms and Conditions

- 1. These terms and conditions ("Terms") govern your participation in the BitOasis USD 30,000 Trading Championship promotion ("Promotion").
- 2. By entering into the Promotion you confirm that you have read, understood and accepted the Terms in their entirety.
- 3. Eligibility Period: The Promotion shall run from March 2, 2022 to March 31, 2022.
- 4. A customer shall qualify for the Promotion if he/she:
- (i) Participants use their BitOasis-registered email address. Participants were properly onboarded on to the BitOasis Platform and successfully traded crypto-assets that are listed on the BitOasis Platform at any time during the Eligibility Period; AND
- (ii) is in good standing with BitOasis and holds an active BitOasis account at the time any award or distribution of prizes is made.
- 5. BitOasis will select the Winning Participants from all eligible entries based on their trading volume and will reward them according to the schedule below:
- A. Participants using the Pro feature will win the following prizes for the biggest trading volume during the competition period:

\$4,000 for the trader with the biggest trading volume.

\$2,500 for 2nd biggest trading volume.

\$1,500 for 3rd biggest trading volume.

All other traders will share rewards from a USD 5000 pool.

- B. Participants using the Core feature will win the following prizes for the biggest trading volume during the competition period:
 - \$6,000 for the trader with the biggest trading volume.
 - \$4,000 for the trader with the 2nd biggest trading volume.
 - \$2,000 for the trader with the 3rd biggest trading volume.
- C. All other traders will share rewards from a USD 5000 pool.
- 6. The reward amount will be deposited in the customer's BitOasis account.
- 7. Within a reasonable period, BitOasis shall notify the Eligible Participants of their prize awards in accordance with Schedule 6 A, 6 B and 6 C.
- 8. Such notifications will be made by e-mail to the Participant's registered email addresses and BitOasis shall not be required to, nor liable for, not having notified Eligible Participants other than by email.



- 9. BitOasis shall make prize distributions by adding the prize amount to the Participants' BitOasis accounts. This prize distribution amount will be in cash AED or SAR if a distribution is made in an alternate currency. BitOasis shall not be required to credit the Participant's bank account or to credit any BitOasis account other than an account held in such person's name.
- 10. BitOasis reserves the right to amend or cancel any terms of the Promotion, or the Promotion in its entirety, in good faith and at any time including changing the Prize Distribution Schedule and/or removing a Participant including if BitOasis reasonably believes that such person has participated in the Promotion fraudulently or with fraudulent intent.
- 11. BitOasis makes no warranty or representation as to the accuracy of any content or updates it publishes in relation to the Promotion including but not limited to leaderboards.
- 12. Except where prohibited, participation in the Promotion constitutes each Participant's consent to BitOasis and its agents' use of Participant's name, likeness, photograph, voice, opinions for promotional purposes in any media, worldwide, without further payment or consideration.
- 13. BitOasis shall not be responsible for: (1) any incorrect or inaccurate information, whether caused by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error that may occur in the administration of the Promotion or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the participation in the Promotion or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, the entrant's sole remedy is another entry in the Promotion, if it is possible. No more than the stated number of prizes will be awarded.

Except where prohibited, Eligible Participant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the Courts of England & Wales; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event lawyer' fees; and (3) under no circumstances will an entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these terms and conditions, or the rights and obligations of the Eligible Entrant and BitOasis in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of England and Wales.
